We are very proud of our logo, and we require you to follow these guidelines to ensure it always looks its best. Our logo is the combination of a simple and modern wordmark with the Magnolia illustrative icon.

The Mississippi Lottery logo's exclusion zone is equal to the cap height of the M in the "MS" of the logo.



Establishing a minimum size ensures the impact and legibility of the logo is not compromised in application.



The Mississippi Lottery logo should never be smaller than 185px in digital or 32mm in print.

LOGOUSAGE:



It is important the appearance of the logo remains consistent. The logo should not be misinterpreted, modified, or added to. No attempt should be made to alter the logo in any way. Its orientation, color and composition should remain as indicated in this document there are no exceptions.



Do not apply a gradient to the icon or wordmark.



Do not rotate the logo.



Do not change the logo color/ tone outside the approved brand colors unless approved by the MLC for special usage.



Do not outline or create a keyline around the logo.



Do not swap the green and blue application on the logo.



Do not change the typeface nor recreate or manipulate the wordmark and the magnolia.



Do not distort or warp the logo in any way.



Do not use any of the logo options on a low contrast background.



All printed/digital material promoting the Mississippi Lottery must include the following:

- Our Play Responsibly logo
- "You must be 21 or older to play."

If the Play Responsibly logo is included elsewhere on the same document, it is not required to be included under the logo. If the Play Responsibly logo is NOT located on the same document, use our Mississippi Lottery logo that incorporates the Play Responsibly logo. Any advertising or signage utilizing the Mississippi Lottery logo must be submitted to the Mississippi Lottery for approval prior to use.






BRAND COLORS

Hypatia Sans Pro is our primary typeface and should be used for all headings and large text uses. It is a geometric sans serif with humanist undertones. Hypatia echoes the basic form of geometric designs from the 1920s and 30s, and adds features derived from classical oldstyle typefaces and inscriptional lettering that give the design a balance between cold geometry and warm organic form. The letters are expressive at larger sizes and are still clear and readable at text sizes in short paragraphs. A wide range of weights increases the family's versatility, and its many alternate glyphs and layout features provide a palette of expressive options.
