

## RULES

1. **NO PURCHASE REQUIRED:** There is no purchase necessary to win; purchasing Mississippi Lottery products does not increase the chance of winning. Limit one entry per person, per drawing. Duplicate entries using multiple email addresses will be disqualified.

2. **WHO CAN ENTER:** The NASCAR-Powerball Playoff promotion is open to Mississippi Lottery Insiders. Lottery employees, retailers and vendors, and their immediate family members residing in their household, are not eligible to win any Mississippi Lottery promotional prizes.

3. **ENTRIES:** Mississippi Lottery Insiders will receive access to an entry form by email.

Each NASCAR-Powerball Playoff will have a unique entry form, and entrants are encouraged to submit entries for each drawing. Each submitted entry is valid for the specific drawing only; entry forms from previous drawings do not carry forward.

Each entry form will include a list of prizes available for the specific drawing. Winners from previous drawings are ineligible to win again in the NASCAR-Powerball Playoff.

4. **DRAWING PROCEDURE:** The pool of entries is comprised of completed entries received each week between 9 a.m. Central Time Monday prior to the draw through 9 a.m. on the draw date. Mississippi Lottery Insiders will receive a link to an entry form by email at the beginning of each drawing period.

Three semi-finalists for the NASCAR-Powerball Playoff will be selected in the April 26, April May 10, May 24 and June 7 drawings; four entrants will be selected in the June 21 and July 5 drawings.

5. **DRAWING METHOD:** NASCAR-Powerball Playoff winners will be chosen by random drawing.

6. **ODDS OF WINNING:** The odds of winning a prize via the NASCAR-Powerball Playoff promotion are based on the total number of entries each week.

7. **PRIZE ALLOCATION:** Each winning entrant in the NASCAR-Powerball Playoff will receive \$2,500 from the Mississippi Lottery; progressing through levels of the NASCAR-Powerball Playoff as conducted by MUSL may qualify an entrant for additional prizes through the NASCAR-Powerball Playoff promotion. Prizes are limited to a maximum of one per person for the duration of the promotion.

8. CONTACTING WINNERS: Each winning NASCAR-Powerball Playoff entrant will be notified by certified mail. If there is no response within 10 days of the Mississippi Lottery receiving confirmation of the certified mail being delivered, the Mississippi Lottery, at its discretion, may randomly choose another qualified entrant to receive the prize from the same pool of entries.

9. WINNER REQUIREMENTS: Each NASCAR-Powerball Playoff promotion winner will be required to submit proper identification and complete a winner claim form – the same process used for prize claims for MLC games. Claims made by mail must be received by the Lottery within the specified prize claim period. The name and physical address on the entry and claim form must match the name and physical address on the identification. The Mississippi Lottery is not responsible for lost or stolen mail, and claims received after the deadline will be rejected.

The Multi-State Lottery Association (MUSL) plans to publicize finalists' names in the NASCAR-Powerball Playoff. Participants selected by the Mississippi Lottery will be required to sign a release form authorizing MUSL to publicize the participant's name, if chosen as a finalist.

10. WINNERS LIST: The Mississippi Lottery will maintain a list of NASCAR-Powerball Playoff winners and may publicize the winners' hometowns or home counties on the Mississippi Lottery website, via social media or other means.

11. NO PRIZE EXCHANGE: All NASCAR-Powerball Playoff promotion prizes will be awarded as described. No substitutions.

12. TAXES: MLC will withhold and deposit all applicable state and federal taxes on behalf of the winner. An IRS Form 1099/W2G will be issued to the winner as required by law.

13. CONTEST ENTRIES AND PRIZE LIMITATIONS: Limit of one entry per person/email address for each drawing. Limit of one prize per person/per household within the NASCAR-Powerball Playoff promotion.

Entries generated by script, macro or other automated means which subvert the entry process are void. If it is discovered entrant has submitted, attempted to enter, or used multiple accounts to enter more than the stated limit, all promotion submissions for the entrant will be disqualified, and the entrant may be barred from future promotions, at the sole discretion of the Mississippi Lottery. All entries become the property of the Mississippi Lottery and will not be acknowledged or returned.

14. RELEASE OF LIABILITY: All entrants in the NASCAR-Powerball Playoff promotion agree the MLC shall have no liability for any personal injuries, death,

property damage, or other damage or expenses resulting from or arising out of any aspect of use or acceptance of the prize.

16. DISPUTE RESOLUTION: The venue for any dispute arising under and/or as a result of the NASCAR-Powerball Playoff promotion shall be the appropriate court in Rankin County, Mississippi.
