- Rules:
- 1. NO PURCHASE REQUIRED:** There is no purchase necessary to win, and purchasing Mississippi Lottery products does not increase the chance of winning. Limit one entry per person, per drawing. Duplicate entries using multiple email addresses will be disqualified.
 - 2. WHO CAN ENTER:** The drawing for the Mississippi Lottery’s 2024 Green for Spring Promotion is open to anyone 21 years or older who has scanned one of the designated QR codes or Lottery Insiders who enter via the e-mailed link. Lottery employees, retailers and vendors, and their immediate family members residing in their household, are not eligible to enter the promotion or win any promotional prizes, including the Mississippi Lottery’s 2024 Green for Spring Promotion.
- Each entry form will include a list of prizes available for the specific drawing. Winners in a 2024 Green for Spring Promotion drawing are not eligible to win again within the same promotion. Entries are limited to one per email address per drawing.

3. DRAWING SCHEDULE: Drawings will be conducted Feb. 5, Feb. 12, Feb. 19, Feb. 26, March 4, March 11, March 18, and March 25, 2023. Entries via QR codes and from Mississippi Lottery Insiders comprise the pool for these drawings.

4. DRAWING PROCEDURE: On Monday, Jan. 29, 2024, the Mississippi Lottery will issue a press release, a post on social media and notice via email to Mississippi Lottery Insiders announcing the Mississippi Lottery's 2024 Green for Spring Promotion. Insiders will receive emails each Monday throughout the entry period. Completed entries must be submitted by 9 a.m. Central Time on the Monday of the drawing.

Each entry form will include a list of each prize available for the drawing. Each submitted entry is valid for the next drawing only. Participants may submit entries for each drawing.

Participants in the drawing for the Mississippi Lottery's Green for Spring Promotion are required to confirm on the entry form indicating he/she is (1) at least 21 years of age and assumes all risks associated with the prizes, and (2) he/she has read the rules and is not a Mississippi Lottery employee, retailer or vendor, or an immediate family member residing in the household thereof.

Each entry form will include a link to the rules, regulations and prize descriptions associated with the promotion.

5. DRAWING METHOD: The Mississippi Lottery's winners for the Mississippi Lottery's 2024 Green for Spring Promotion will be chosen by random drawing.

6. ODDS OF WINNING: The odds of winning each category of Mississippi Lottery's Green for Spring Promotion drawings are based on the total number of entries for each drawing.

7. PRIZE ALLOCATION: For Drawings 1 through 7, prizes awarded will be specified in order, i.e., the first name drawn will be awarded the 1st Prize, the second name drawn will be awarded the 2nd Prize, and the third name drawn will awarded the 3rd Prize. Alternates will be drawn in case a prize winner fails to respond. Prizes are limited to a maximum of one per person for the duration of the promotion. For Drawing 8, a total of 10 entries will be drawn, with each drawn entry receiving \$500.

8. CONTACTING WINNERS: Each winning entrant in the drawings for the Mississippi Lottery's Green for Spring Promotion will be notified by certified mail. Winners have 10 days from the date the Mississippi Lottery receives confirmation of certified letter delivery to respond as described in the following Paragraph 9. If a winner fails to respond within the time period, an alternate will be selected in the order drawn and notified, until a response is received. If both the original winner and the alternate fail to respond, the prize is forfeited.

9. PRIZE REDEMPTION: All prize winners will be required to submit proper identification and complete a winner claim form to claim a prize – the same process used for prize claims for MLC games. Prize winners will be mailed the claim form and may submit their claim by mail along with a photocopy of the required identification. The physical address on the entry and claim form must match the physical address on the identification. Completed claim forms must be received within 30 days of notification of winners. The Mississippi Lottery is not responsible for lost or stolen mail.

10. WINNERS LIST: The Mississippi Lottery will maintain a list of winners of the Mississippi Lottery's 2024 Green for Spring Promotion and may publicize the winners' hometowns or home counties on the Mississippi Lottery website, via social media or other means.

11. NO PRIZE EXCHANGE: All Mississippi Lottery's 2024 Green for Spring Promotion prizes will be awarded as described. No substitutions.

12. TAXES: All federal, state and local taxes on the total prize value, if applicable, are the responsibility of the winner. MLC will withhold and deposit the initial state and federal taxes on behalf of the winner, as required by law. An IRS Form W-2G/1099 will be issued to the winner if required by law.

13. CONTEST ENTRIES AND PRIZE LIMITATIONS: Limit of one entry per person/email address for each drawing. Limit of one prize per person/per household within the 2024 Green for Spring Promotion.

Entries generated by script, macro or other automated means which subvert the entry process are void. If it is discovered an entrant has submitted, attempted to enter, or used multiple accounts to enter more than the stated limit, all promotion submissions for the entrant will be disqualified, and the entrant may be barred from future promotions, at the sole discretion of the Mississippi Lottery. All entries become the property of the Mississippi Lottery and will not be acknowledged or returned.

14. DISPUTE RESOLUTION: The venue for any dispute arising under and/or as a result of the 2024 Mississippi Lottery's Green for Spring Promotion shall be the appropriate court in Rankin County, Mississippi.
