2024 Summer of Fun Promotion Rules

- 1. NO PURCHASE REQUIRED: There is no purchase necessary to win; purchasing Mississippi Lottery products does not increase the chance of winning. Limit one entry per person, per drawing. Duplicate entries using multiple email addresses or any other method will be disqualified.
- 2. WHO CAN ENTER: The 2024 Summer of Fun promotion is open to anyone 21 years or older. Lottery employees, retailers and vendors, and their immediate family members residing in their household, are not eligible to win any 2024 Summer of Fun promotional prizes.
- 3. ENTRIES: Each 2024 Summer of Fun promotion drawing will have a unique entry form, and players are encouraged to submit entries for each drawing. Each submitted entry is valid for the specific drawing only; entry forms from previous drawings do not carry forward.

Each entry form will include a list of prizes available for the specific drawing. Winners from previous drawings in the 2024 Summer of Fun promotion and members of their respective households are not qualified to win again in subsequent drawings in this promotion. Entries for each drawing are limited to one per email address.

Entry forms may be accessed by scanning 2024 Summer of Fun promotion QR codes at lottery play centers, lottery retailer in-store information monitors, or in Mississippi Lottery TV commercials. Mississippi Lottery Insiders will receive access to an entry form by email.

4. DRAWING PROCEDURE: The pool of entries is comprised of completed entries received each week between 9 a.m. Central Time Tuesday the week prior to the draw through 9 a.m. Central Time on the draw date. Mississippi Lottery Insiders will receive a link to an entry form by email each week.

Drawings for first-, second-, third- and fourth-place prizes will occur May 21, May 28, June 4, June 11, June 18, June 25, July 2, July 9, July 16, July 23, July 30, Aug. 6, Aug. 13, Aug. 20, and Aug. 27, 2024.

- 5. DRAWING METHOD: 2024 Summer of Fun promotion winners will be chosen by random drawing.
- 6. ODDS OF WINNING: The odds of winning a prize via the 2024 Summer of Fun promotion are based on the total number of entries in each drawing.
- 7. PRIZE ALLOCATION: The prizes awarded will be specified in order on the entry form for each drawing. The prizes awarded in each 2024 Summer of Fun promotion drawing shall be allocated in the order of the entries selected.

8. CONTACTING WINNERS: Each winning 2024 Summer of Fun promotion entrant will be notified by certified mail. If there is no response by the prize winner within 15 calendar days following the Mississippi Lottery's receipt of confirmation of the certified mail delivery, an alternate winner of the prize may be selected, the prize may be held for a later drawing in the 2024 Summer of Fun promotion, or the prize may be held for later promotion, in the Mississippi Lottery's sole discretion.

- 9. WINNER REQUIREMENTS: Each 2024 Summer of Fun promotion winner will be required to submit proper identification and complete a winner claim form the same process used for prize claims for MLC games. - 10. PRIZE PICK UP: 2024 Summer of Fun promotion winners will have 30 calendar days following the Mississippi Lottery's receipt of confirmation of the certified mail delivery of the notification letter to arrange to take possession of his/her prize as directed by the notification letter.
- 11. WINNERS LIST: The Mississippi Lottery will maintain a list of 2024 Summer of Fun promotion winners and may publicize the winners' hometowns or home counties on the Mississippi Lottery website, via social media or other means.

- 13. FUN WITH TAXES: The initial sales taxes, initial title and initial registration fees associated with the acceptance of the prize shall be paid by the MLC.
